

## Blind Date Cake

## From Nancy Lacy

1 cup chopped dates

1<sup>1</sup>/<sub>4</sub> cup boiling water Simmer dates in water for 5 minutes, let cool.

Add 1 tsp baking soda.

Cream together:

1 cup sugar

<sup>1</sup>/<sub>2</sub> cup shortening (or 1 stick softened butter)

2 eggs

### Add:

1 tsp vanilla

 $1 \frac{1}{4}$  cup flour

- 1 Tbsp cocoa
- 1 tsp salt
- Then add date mixture.

For topping:

 $\frac{1}{2}$  cup sugar

6 oz chocolate chips

Pecan pieces

Bake @350 for 35 minutes.
